## Where We Stand:



#### **Immigration**

- Cap at 100,000-150,000 per year
- Focus on economic immigration
- Repeal Multiculturism Act and funding
- Immigrants require Canadian values
- Encourage private refugee sponsors
- Withdrawal from UN Pact on Migration
- End "Birth Tourism"

#### **Income Tax**

- 0% up to \$15,000
- 15% from \$15,001 to \$100,000
- 25% above \$100,001

#### **Dairy/poultry Grocery Cost**

- Abolish Supply Management, reducing grocery prices
- Save the average family \$400/year

- Employ existing Criminal Code for libel & slander issues
- NO to Section 13 allowing political parties to bypass Criminal Code to criminalise speech of their choice

#### **Corporate Welfare**

Completely abolish

#### **Equalisation payments to Provinces**

- Reform & reduce to make it fair and avoid dependency
- Inter-Provincial Trade
- Remove trade barriers

#### **Budget**

Balanced within 2 years

#### **International Trade**

Negotiate fair free trade deals

#### **Crown Corporations**

 More competition & appropriate privatisation to achieve cost reduction

#### **Foreign Aid & Handouts**

- ELIMINATE all unnecessary foreign aid.
- Focus on emergency humanitarian aid

#### Constitution

Govern in accordance with Canadian Constitution
more authority given to Provinces & Territories

#### <u>Taxation – general</u>

Reduce both levels and tax code complexity

# Paris Climate Accord & meeting emissions targets

- NO to Paris Climate Accord
- Focus on environmentally sound solutions for clean air, water, and land
- No economic distortions (tax credits, carbon tax, etc.)
- Encourage private companies to develop environmentally sound products and services by enabling 100% write-off of initial business expenses to ALL business in 1st year

#### **Energy sector**

- Use federal jurisdiction & powers to immediately enable nationwide pipelines
- Approvals & construction dependent on national benefit & security
- Repeal C-48 & C-69
- Locate Private buyer for Trans Mountain Line by removing gender studies from pipeline negotiations

#### **Firearms policy**

- REPEAL C-71; Replace Firearms Act to respect lawful owners
- Classification by function, not politics; Focus on safety, training & restricting criminals

#### **Farm Tax**

• REDUCE to 10%
